

INFORMATION IN REGARD TO THE TYPE AND VOLUME OF THE PERSONAL DATA PROCESSED BY THE CONTROLLER BOLSA EOOD

In accordance with GDPR, we hereby inform you that over the course of its activity BOLSA9 EOOD collects and processes your personal data.

Please read the information given below in regard with the type and volume of the personal data we collect and process, as well as its protection and your rights.

I. Controller's information and contact details:

BOLSA EOOD UIC: 131568518, with seat and management address in Sofia, 18 Tsar Osvoboditel blvd., represented by the manager Stanislava Georgieva;

II. Purposes of the data processing

BOLSA EOOD collects and process the following personal data for applicants for a membership: three names, date of birth, address, phone number, email address, photo, employer's name and job position, as well as contact information with a person, chosen by you, for the purposes of membership subscription.

The legal ground for the collection and processing of this personal data is the agreement for membership in the Residence club.

Some of the collected date is necessary under the applicable law.

III. Recipients of personal data:

In the Controller's organization recipients of personal data are: the manager of the company, the Main hostess and the administrative secretary.

IV. Terms for processing personal data:

The term for processing personal data of subject in category "Clients" is 5 years as of termination of the membership.

V. Rights of the data subjects

You have the following rights:

- **Right of information and access** to your personal data: you have the right to receive from us confirmation as to whether or not your personal data is being processed, and, where that is the case, access to the personal data;
- **Right to rectification**: in cases where you have found the personal data we have for you is incomplete or inaccurate you have the right to request its completion or rectification.
- **Right to erase** (to the extent that processing is necessary for the Controller to execute legal obligation, for reasons of public interests for legal claims);
- **Right to restriction of processing** (to the extent that processing is necessary for the Controller to execute legal obligation, for reasons of public interests for legal claims): in the cases when you have concluded that the personal data is not correct or when you have doubts about the lawfulness of the data processing you may request the Collector to pause the processing of your data until the issues have been resolved;
- **Right to object**: you have the right to object against the processing when you have doubts about the legitimate interest of the Controller for that specific processing;
- **Right to data portability**: you have the right to receive the personal data concerning you in a structured, commonly used and machine-readable format and you have the right to transmit that data to another controller, if the processing is based on consent or on a contract and the processing is carried out by automated means.
- **Right to a claim** before the Commission for personal data protection;

VI. Mandatory data

Due to the specific relation between the Collector and you, you need to provide a specific information in order for the controller to be able to provide its services. For concluding a membership agreement, the following data is mandatory: three names, date of birth, address, phone number, email address, photo, employer's name and job position, as well as contact information with a person, chosen by you. In case you do not wish to provide this information we will be not able to enter into a membership agreement with you.

For granting access to the building of the Residence club, it is mandatory for the subject to provide a photo of himself/herself. In case you do not provide such a photo, the collector will not be able to fulfil its obligations under the Membership agreement.
